BCAH Board Meeting Wednesday, November 29th, 2023

- 1. Acceptance of meeting agenda Nicole suggested adding the TCIH survey as item 8 in the agenda. Lynn moved to accept the agenda all were in favour.
- 2. Acceptance of minutes from last meeting (Pre-AGM 1st Nov, 2023) Marie moved to accept the minutes and all were in favor.
- 3. Review of minutes from AGM (November 4, 2023): Marie reviewed the minutes of the AGM with the board members and all were ok with it. These minutes would be moved in the next AGM for acceptance by all the members. Marie also posted the minutes of AGM-2022 on the website.
- 4. Board updates from Treasurer; Membership; One member paid her dues and another member sent a \$25 application fee. Marie will download its pdf from the website and email to board members, Lynn and Heather can accordingly schedule an interview with her.

- 6. CHA & CCFH updates CHA had a meeting and are still waiting to hear from the insurance companies. They are looking for donations and social media followers, Marie will send their information in the MailChimp.

CCFH: There was an international press conference on Wednesday that Marie attended. They presented the results of the survey they had conducted in 40 countries. They will send a copy of the press release to everyone who attended it.
