BCAH Board Meeting Wednesday December 4, 2024

- 1. Acceptance of meeting agenda
 - Accepted all in favor
 - Nathalie, Nicole, Monaliz, Lynn, Marie and Paige in attendance
 - Minute taker: Paige
 - Absent: Jenny
- 2. Welcome to new board members & getting set up with email and transfer of duties
 - New members Paige and Monaliz
 - Heather transferred director one email
 - Nicole is director two email
 - ACTION: all emails go to official board emails, not personal emails
 - Next Wednesday at 1pm with Harkirat, Marie, Nathalie and Paige to transfer everything over for the secretary role
 - Be careful with email to the treasurer the email is not like the others
- 3. Acceptance of minutes from last meeting (November 6, 2024)
 - All accepted some edits to the last minutes
 - Changes were grammatical in nature, and discussion to add "Z" to indicate Christy's last name
- 4. Review of draft AGM Minutes
 - Marie edited for clarification regarding showing a draft of a presentation, and adding "recently" to indicate time, as well as one grammatical change to Sunlife.
 - AGM minutes remain a draft until the next AGM

9. Wellness Show Vancouver Feb 2024 – booth is booked

- Marie sent application form last Wednesday, put the fee on her personal credit card and has already been reimbursed by Nathalie
- February 1 and 2, 2025 (set up day is Friday, January 31)
- ACTION: synopsis of do's and don'ts of the exhibitor handbook needs to be created (Paige has offered to do this)
- Marie sent back: Notice of Acceptance, Mainstream & Social Media Relations Form, Displays of Products and Services Form (decided on indicating only homeopathic products and homeopathic products on this form)
- Since past the due date of the Badge Forms will not receive individual names on the badges, just
 the company/organization names we will only get two badges with the booth; additional
 badges will be available for \$8 each before and on the day of; Marie suggested 5 people per
 day decision to order two extra badges (total of four)
- No extra tickets ordered on the Exhibitor Tickets Order Form
